Elections for Executive committee of TOS &
Members of Scientific Committee

Date 21st April 2022

As per the powers vested in me as Hon. Gen. Secretary TOS, I invite nominations for the following positions as per the eligibility criteria enumerated against each post. The nominations should be proposed and seconded by one member each and should be accepted by the candidate. The TOS life membership numbers of the proposer, secondor and the candidate should be clearly mentioned. The year of joining APOS/TOS of the candidate should also be mentioned to decide eligibility. The years in which he/she was an office bearer / member of Managing Committee should be mentioned for the post of Vice President and Hon. Gen. Secretary.

Sno:	Honorary Position	Term	Eligibility Criteria
1	Vice President	1 year	Life member APOS/TOS of at least 8 years in good standing and should have been an office bearer / member of managing committee in the past for at least one term.
2	Hon. Gen. Secretary	3 years	Life member of APOS/TOS at least 8 years in good standing and should have been an office bearer / member of managing committee in the past for at least one term.
3	Joint Secretary	3 years	Life member of TOS of at least 5 years of good standing.
4	Treasurer	3 years	Life member of TOS of at least 5 years of good standing.
5	Chairman Scientific Committee	3 years	Life member of TOS of at least 5 years of good standing. He /She should have rich Scientific Experience and Scientific publications and presentations to his/her credit.
6	Chairman Academic & Research Committee	3 years	Life member of TOS of at least 5 years of good standing.
7	Editor – Publications	3 years	Life member of TOS of at least 5 years of good standing.
8	Members – Scientific Committee, Total 4 Posts	3 years	Life member of TOS of at least 5 years of good standing.
9	Members – Academic & Research Committee, Total 3 Posts	3 Years	Life member of TOS of at least 5 years of good standing.
10	Members – Editorial Committee, Total 3 Posts	3 Years	Life member of TOS of at least 5 years of good standing.

Date of Scrutiny – 7th June 2022 –5 PM.

Last Date of Withdrawal – 30th June 2022 –5 PM

Election if required shall be during the General Body meeting on 23rd July 2022 at Warangal.

Elections shall be conducted in accordance with the Bylaws of TOS Constitution.

Article VIII: Election Procedure

1. Honorary General Secretary shall invite nominations for various posts for election, a minimum of 90 days before the conference date. The nominations should be received on or before the date specified by the secretary.
2. Each nomination should be proposed and seconded by one Life member each and should be accepted by the candidate. The date of candidate joining the society as life member and years in which he/she was a member of the managing committee should be clearly mentioned in the proposal, to decide the eligibility.
3. No member shall propose or second more than one member for that particular post. Similarly for members of scientific committee / ARC and Editor Publications, no member can propose more members than the available positions. In such a situation, all such nominations though being valid shall be disqualified.
4. The last date for withdrawal of nominations shall be as decided by the secretary.
5. Only Life members in good standing are eligible for voting. The President will constitute an Election Commission of 3 Past Presidents. Senior most of them will be chief election officer and also the returning officer.
6. Voting, if required, shall be by secret ballot or show of hands as decided by the Chief election officer.
7. In case of a tie, the casting vote of the President shall decide the result.
8. If no valid nomination is received by post or otherwise, before the stipulated date, nominations shall be called from the floor of the general body, by the chief election officer, appointed by the president. In this case the candidate should be present in the meeting to give consent for the nomination.
9. The decision of the election commission is final. In case of any dispute, the general body will decide by a majority vote.
